



Limited Equine Warranty

2/12/2019

North West Rubber Ltd. (NWR) offers the following limited warranty on the Classic ¾" and Max mats produced for equine use products:

- NWR** warrants that all products it supplies will meet the applicable product specifications specified by **NWR** and will be free from defects in material and workmanship at the time of shipment from **NWR** and for 5 years (the "Initial Warranty Period") thereafter. If defects appear during the Initial Warranty Period, **NWR** will, at its sole option and as the customer's exclusive remedy, repair or replace the defective product. If there are defects in material and workmanship subsequent to the Initial Warranty Period and up to fifteen (15) years from the date of delivery, **NWR** will replace the products and charge the customer the following amounts based on current prices (plus tax) at the time of replacement:

One to Five Years -- 0 %

Six years ----- 10 %	Seven Years ----- 20 %	Eight Years ----- 30 %
Nine Years ----- 40 %	Ten Years ----- 50 %	Eleven Years ----- 60 %
Twelve Years ----- 70 %	Thirteen Years ----- 80 %	Fourteen Years ----- 90 %

Note: *The rate of wear of ¾" is directly connected to the volume of traffic and use. Any warranty calculations will take this into account.*

- The Warranty only applies provided that **NWR** receives written notice (mailed to address below) of the defect along with proof of purchase. To claim under the Initial Warranty Period, the receipt of the required information by **NWR** must be within ten (10) days of the end of the Initial Warranty period.
- This Warranty applies to materials only and does not include any other cost, such as delivery, installation, removal or labor costs. This warranty is not transferable.
- Any defect determined by **NWR** not to be due to a defect caused by **NWR** (e.g., if it is attributable to alteration, modification, negligence or misuse by the customer or another person) is not covered by this Warranty. The normal wear and aging of your product due to normal usage is not covered by this Warranty.
